PENNSBURY SCHOOL DISTRICT MEMORANDUM OF UNDERSTANDING

Between the Board of School Directors for the Pennsbury School District and the Pennsbury Educational Support Professionals Association (PESPA)

On this 16th day of June 2022, this MEMORANDUM OF UNDERSTANDING (hereinafter referred to as the "MOU") is entered into by and between the Pennsbury Educational Support Professionals Association ("PESPA") and the Pennsbury School District (hereinafter referred to as the "District").

WHEREAS, the District and PESPA are parties to a Collective Bargaining Agreement covering PESPA Bargaining Unit Members (the "Members") over the time period of July 1, 2017 through June 30, 2022 (hereinafter referred to as the "Current CBA"); and

WHEREAS, the District and PESPA are parties to a Successor Collective Bargaining Agreement covering PESPA Bargaining Unit Members (the "Members") over the time period of July 1, 2022 to June 30, 2027 (hereinafter referred to as the "Successor CBA"); and

WHEREAS, the Successor CBA introduces certain salary adjustments for the job classification of "Secretary/Clerk, High School"; and

WHEREAS, the TA's changes will be effective with a new CBA on July 1, 2022; and

WHEREAS, the District and PESPA desire to introduce this change in advance of the aforementioned effective date of the Successor Agreement.

NOW, THEREFORE, the District and PESPA hereby mutually agree to the following provisions:

1. Compensation for the job classification "Secretary/Clerk, High School" will be as follows effective December 19, 2021 through June 30, 2022. Payment for the time served prior to the signing of this MOU shall be made retroactively.
